Rules of Oral Hearing Procedure

**Regarding an Anti-Dumping Investigation on Stainless Steel Pipes and Tubes
originating in the Republic of Korea, the People's Republic of China, Chinese Taipei
and the Socialist Republic of Vietnam**

Wednesday, July 27th, 2016, 10.00 a.m.

Meeting Room No. 1601, 16th Floor, Department of Foreign Trade Building

1. The Department of Foreign Trade will not respond or answer any questions that might be raised by the interested parties during the hearing.
2. Any interested party wishing to present the evidences, views, or comments during the hearing is requested to submit the written statements by **22 JUL 2016, 4.30 p.m.** Bangkok time. On the date of the hearing, every argument and/or information given verbally, along with relevant supporting documents, shall be submitted in written form. Any additional views or comments and/or information, apart from initially submitted documents, which might be raised during the hearing, shall be submitted in written form to the Department of Foreign Trade by **August 1st, 2016, 4.30 p.m.**
3. The hearing will be conducted in Thai.
4. Each interested party will be allowed 15 minutes to present evidences, views or comments. The sequence of presentations will be notified by the Chairperson on the date of the hearing.
5. The representative (s) of each interested party will be allowed to present evidences, views or comments one time per person during the allotted time. The Chairperson is within his/her rights to stop any representatives who speak more than the specified time limit.
6. The Chairperson is entitled to amend any regulations that are not initially mentioned in the Rules during the hearing, whenever deemed appropriate.
